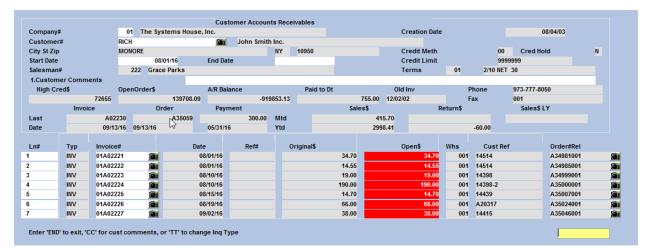
MDS Quick Guide Entering or Reversing a Cash Batch

Overview :

The MDS System records cash reciepts to allow you to apply payments made by customers to invoices. It also allows for on account payments and miscellaneous cash application. This quick guide will walk you thru the steps to reverse a batch. Generally this process is used if you apply the cash to the wong customer or for the wrong amounts.

First I will apply payments to multiple Invoices for a specific customer.

Then I will reverse the batch by applying negative values to the batch, checks and each invoice to reverse the payment transactions opening the invoices back up.
