Regarding: Title II of the Drug Quality and Security Act - Sandoz Inc. Updates

Dear Valued Partner,

The Drug Quality and Security Act (DQSA) was signed into law on November 27, 2013. Title II of DQSA, the Drug Supply Chain Security Act, identifies the requirements for building an electronic, interoperable system to identify and trace prescription drugs distributed in the United States.¹ On June 30, 2017, the FDA issued a draft one year non-enforcement guidance to the November 27, 2017, requirements. For preparation of the next manufacturing DQSA milestones and taking in consideration the non-enforcement draft and multiple solutions to comply with the regulation, Sandoz is providing an update on our ongoing efforts of Lot Level Tractability and Product Serialization.

As of November 27, 2017:

- Sandoz intends to have all products packaged by March 01, 2018 imprinted with a 2-D Data Matrix on each sellable unit and homogeneous shipper that includes the GTIN, a 14 digit numerical Serial Number, Lot and Expiry and human readable print of the same according to GS1 standards.
- Full cases will have an HDA (Healthcare Distribution Alliance)-compliant case label. Partial Cases will be serialized with an SSCC (Serial Shipping Container Code) label.
- Sandoz inventory of non-serialized product after November 26, 2017 will continue to be sold until such stock is depleted unless prohibited by FDA grandfathering guidance
- Transaction Information, history and statement will be sent electronically using an ASN (Advance Shipping Notice) through Sandoz's third party supplier, TraceLink. If you are not connected to Tracelink, a copy of the DSCSA compliant Packaging list will be obtainable through Sandoz's web portal "Customer Connect".
- In 2017, Sandoz will gradually introduce serialized product by SKU, after exhausting non-serialized inventory.
- Sandoz will not provide serial number verification services prior to November 27, 2017.
- Sandoz will communicate by November 2017, our processes for receiving enhanced verification request
- Sandoz is evaluating options on how best to communicate with to our customer's information on Sandoz product master data –GTIN (Global Trade Information Number) information. Sandoz is investigating Orgin or another third party provider
- Currently, Sandoz has no plans to implement aggregation for 2017. Sandoz will continue to keep you informed on our
 progress in complying with the DQSA requirements

As of November 27, 2019

- To support authorized trading partner's need to verify sellable returns prior to re-distribution, Sandoz is working to provide a customer-friendly technical solution. Sandoz is participating in the HDA Verification Router Service work group to support the development of such solution.

As a Valued Customer, Sandoz would like your feedback as to your intentions to participate in the HDA verification process, and your plans for verification of serial numbers (with manufacturers).
