ACCOUNTS PAYABLE OVERVIEW

INTRODUCTION

The accounts payable module of TSH's Master Distributor System is designed to and automate the payment of vendor invoices. It is fully integrated into the general ledger system.

The module functions on an open item accrual accounting basis.

It contains the following features:

VOUCHER INPUT

1. The system is multi company and multi bank by design. Vendor balance and activity fields are maintained by company.
2. Invoice and cash discount due date are automatically computed based on terms resident on each Vendor's file (Vend.Det).
3. Discount amounts are automatically computed based on the vendor terms stored in the Vendor file (Vend.Det), applied to the discountable portion of the invoice. The computed discount amount can be overridden by the entry of a discount amount or percentage during voucher entry
4. The automatic derivation of general ledger distribution coding and payment bank assignment is based upon information contained in the Vendor file.
5. Provision for the entry of temporary vendors is also available. These vendors are generated during voucher input, and are purged after the check has been written, balance is 0 and check is older than 65 days.
6. Full override on all automatic computations.
7. Automatic voucher number assignment with separate sequence control for each company.
8. Proper processing of manually prepared checks and bank transfers, including letter of credit payments.

ACCOUNTS PAYABLE OVERVIEW

VOUCHER INPUT (Continued)

9. The recurring vouchers module provides for the periodic vouchering of bills paid on a recurring basis, such as rent bills or loan payments. The user can specify the amount, frequency, and number of payments for each recurring item.
10. Optional batch control function for voucher entry.
11. Optional AP/PO receiving interface at voucher entry time, to insure vendor invoiced amount match the PO received value.

CHECK WRITING AND CASH FORECASTING

1. Cash requirements forecasting is facilitated through the flexible accounts payable payment schedule report.
2. Automatic disbursement of payable items based on payment due date.
3. Selective item disbursement (including partial payment) when full automatic processing is not desired.
4. Protection against negative disbursements.
5. The bank from which the check is to be written, may be specified at the time of check writing, or at the time of voucher input.

ACCOUNTING

1. The ability to post to several months (and even accounting years) simultaneously.
2. Complete batch audit controls for all transactions.
3. Proper accounting treatment of voucher deletions and check reversals.
4. Bank reconciliation procedures.
5. Automatic posting to the general ledger of all disbursements and expense distributions.

ACCOUNTS PAYABLE OVERVIEW**ACCOUNTING (Continued)**

6. Monthly summary journals supporting general ledger postings.
7. Optional interfaces with purchasing, inventory, and job costing modules.
8. Vendor activity and performance reporting.
9. Full interactive prompting of all operator instructions is provided to insure ease of use.
10. Optional capability to divide the fiscal year into 12 or 13 fiscal periods.
11. Optional letter of credit tracking and open exposure reporting.

PARAMETERS USED IN THE ACCOUNTS PAYABLE AND GENERAL LEDGER SYSTEM

PARAMETER USED IN ACCOUNTS PAYABLE SYSTEM

The following parameters are used by the accounts payable system.

31. Is a job number used (Y/N)
32. The number of months in the future allowed in voucher input and voucher maintenance. This is checked during voucher input/maintenance to determine if the fiscal period is in the allowable range.
33. The number of months in the future allowed in cash disbursements.
34. Indicator to determine if batch controls are to be used in voucher input (Y/N).
35. Indicator to determine if the bank number is entered at cash disbursement time for regular (machine) check (Y or NULL).
36. A 'Y' in this attribute indicates the use of a 13 fiscal period year.

PARAMETERS USED IN THE GENERAL LEDGER SYSTEM

37. The number of digits of suffix in division. If null or 0, then division coding is not in use for financials.
39. A 'Y' in this attribute indicates the use of the letter of credit system. If this is set to 'N', letter of credit information cannot be entered.
40. A 'Y' in this attribute indicates the use of accounts payable/purchase order interface in voucher input.
72. Receiver maintenance average cost recalculation option
 0. Do not recalculate average cost.
 1. Recalculate average cost from the Fifo file.
 2. Recalculate average cost from the Lifo file.

If the general ledger distribution Cadf record has a category of "I" and the flag is set to 'Y' the receiver and purchase order information must be entered and validated.

FILE MAINTENANCE PROGRAMS

This section describes the maintenance programs provided to establish the master files used by the accounts payable/general ledger module.

The files included are:

1. VENDOR MASTER FILE
2. VENDOR DETAIL FILE
3. CHART OF ACCOUNTS DESCRIPTION FILE
4. CHART OF ACCOUNTS SUFFIX DESCRIPTION FILE
5. JOB DESCRIPTION FILE
6. GENERAL LEDGER SOURCE CODE DESCRIPTIONS
7. BANK MASTER
8. COMPANY MASTER

MASTER FILE MAINTENANCE FUNCTION KEYS

The first 8 function keys on your keyboard (F1-F8) are reserved for special functions in the MDS master file maintenance programs.

They appear on the last line of the screen as follows.

FUNCTION KEY DEFINITION

HELP

The HELP function is available by pressing the F1 function key. Help text is set up as two layers. By pressing F1 at the first field on the screen, an overall description of the master file will be displayed. If F1 is pressed at a specific field within the master file a detailed description of the field and its use will be displayed.

END

The END function is available by pressing the F2 function key. This feature eliminated the need to manually type the word "END" at the end of a program after accepting the data.

INSERT

The INSERT function is available by pressing the F3 function key. The insert mode feature allows insertion of words or numbers into an existing text. Simply bring your cursor to the line or position in which you wish to insert and press F3. For example, if in a master file you wish to insert additional words into a description field or correct a spelling error, you may use the insert function to do so, rather than retype the text.

LDELETE

The LDELETE (line delete) function is available by pressing the F4 function key. The LDELETE function allows you to delete a line from the master file, in place of the *, which is used in older versions of the system. Simply bring the cursor to the line or field you wish to delete and press F4.

MASTER FILE MAINTENANCE FUNCTION KEYS

PREV PAGE

The PREV PAGE (previous page) function is available by pressing the F5 key (SHIFT F1 for terminals supporting only 4 function keys). This function would be used for master files which contain multiple input screens, and will allow easy paging to additional screens. This function will be used simultaneously with the NEXT PG (next page function see next item) function to move back and forth between the screens.

NEXT PG

The NEXT PG (next page) function is available by pressing the F6 function key (SHIFT F2 for terminals supporting only 4 function keys). This function would be used for master files which contain multiple input screens, and will allow easy paging to additional screens. This function will be used simultaneously with the PREV PG (previous page function see item above) function to move back and forth between the screens.

INQUIRY

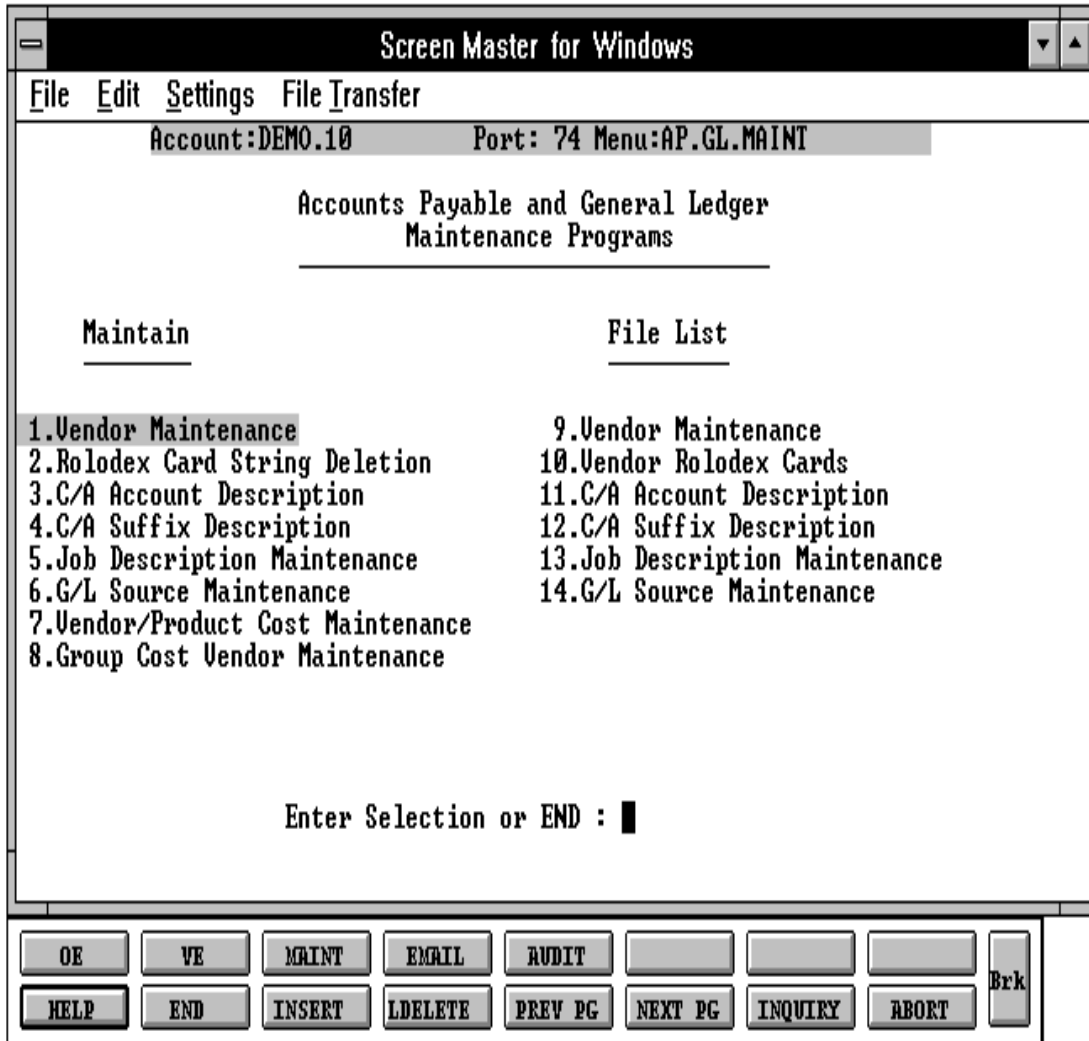
The INQUIRY function is available by pressing the F7 function key (SHIFT F3 for terminals supporting only 4 function keys). This function allows the operator the flexibility to display items in the master file already entered and to display other master files used within the file being created. Example: The product master file. At the first prompt for product number, if F7 is pressed an inquiry can be made to display products on file (to eliminate duplication). If you press the F7 key at another field for example product type (which is another master file) the system will display product types on file to help the operator in selecting which product type best fits the product being created. As you can see the inquiry function can be a very useful tool when creating or maintaining master files.

ABORT

The ABORT function is available by pressing the F8 function key (SHIFT F4 for terminals supporting only 4 function keys). This function is used to end a program without applying changes or additions made and should only be used if you DO NOT want the changes to be updated to the file. If used, the record will be filed as it was before the operator accessed it, in other words, as though no changes were made.

The function keys listing above only apply to master file maintenance programs.

OVERVIEW

The vendor maintenance program establishes and updates the two master files pertaining to each vendor.

A. VENDOR MASTER FILE

One record is established on file for each vendor with which business is done. This record contains master file data such as:

1. Name and Address
2. Contact and Telephone
3. Standard General Ledger number (UP TO 4)
4. Duns #
5. Purchase Order Address
6. Correspondent Bank

The key to the Vendor file is variable, and is established by the MDS customer. The prompt mask and validation pattern is stored in the company record, and retrieved for use in this program. The format of the vendor number may be from 1 to 8 alphanumeric characters.

VENDOR FILE MAINTENANCE**B. VENDOR DETAIL FILE**

This file contains one record for each vendor, for each company with which that vendor does business. In this record information which would vary by company is entered such as:

1. Bank number
2. Discount percent
3. Standard due days
4. Standard discount days
5. Cutoff date for PROX dating
6. Due Date for PROX dating
7. Discount Date for PROX dating

NOTE: Prox and regular dating are mutually exclusive. Thus if (3 or 4) has been entered, 6 or 7 cannot be entered, and vice versa.

The logic of PROX dating, is as follows:

If the invoice date \leq to the cutoff date, the due date is the following month, on that date. If beyond the cutoff date, the invoice will be due on the due date but a month later.

The same logic would apply if a discount was involved.

If the vendor is a new vendor, the prompt will be:

NOT ON FILE, CREATE IT (Y/N)

'Y' will allow you to create a new vendor, 'N' will clear the screen and re-prompt for vendor number. If you are doing maintenance on an existing vendor, all the vendor master details will be displayed and you will be prompted for line number to change.

VENDOR FILE MAINTENANCE

B. VENDOR DETAIL FILE (Continued)

After you have completed the Vendor Master file you will then input the Vendor Detail file information. If you want to make a change to the Vendor Detail, you must input the vendor number, accept the Vendor Master and then change the Vendor Detail.

If you are deleting a vendor, you must delete the Vendor Detail and then the Vendor Master record.

OVERVIEW

When option 10 is selected from the selection screen, the Vendor file analysis and listing process is initiated. The user is presented with several options:

OPERATING INSTRUCTIONS

VENDOR FILE REPORTS

- 1. ANALYSIS**
- 2. LISTING**
- 3. CONSOLIDATED**

ENTER OPTION OR 'END'

DO YOU WANT ONE COMPANY OR ALL (1/A):

Enter 'A' for all companies. If you enter '1' for a specific company number the operator will be prompted:

ENTER COMPANY NUMBER OR 'END'

Enter a specific company number or 'END' to return to the selector.

DO YOU WANT TO SELECT A RANGE OF VENDOR NUMBER (Y/N):

Enter 'N' for all vendors. If you enter 'Y' the operator will be prompted:

VENDOR MAINTENANCE**OPERATING INSTRUCTIONS (Continued)****ENTER STARTING VENDOR NUMBER:****ENTER ENDING VENDOR NUMBER:**

Enter the vendor starting and ending number.

If the listing option is selected, each vendor's name, address, and terms codes are printed on the report. If the analysis option is selected, the dollar amounts disbursed month-to-date, year-to-date and last year are printed, as well as the last payment date amount, and check number in addition to the listing information. If the consolidated option is selected, you will receive the same information as the analysis option, but consolidating the companies.

After the report is produced, the selection screen is redisplayed.

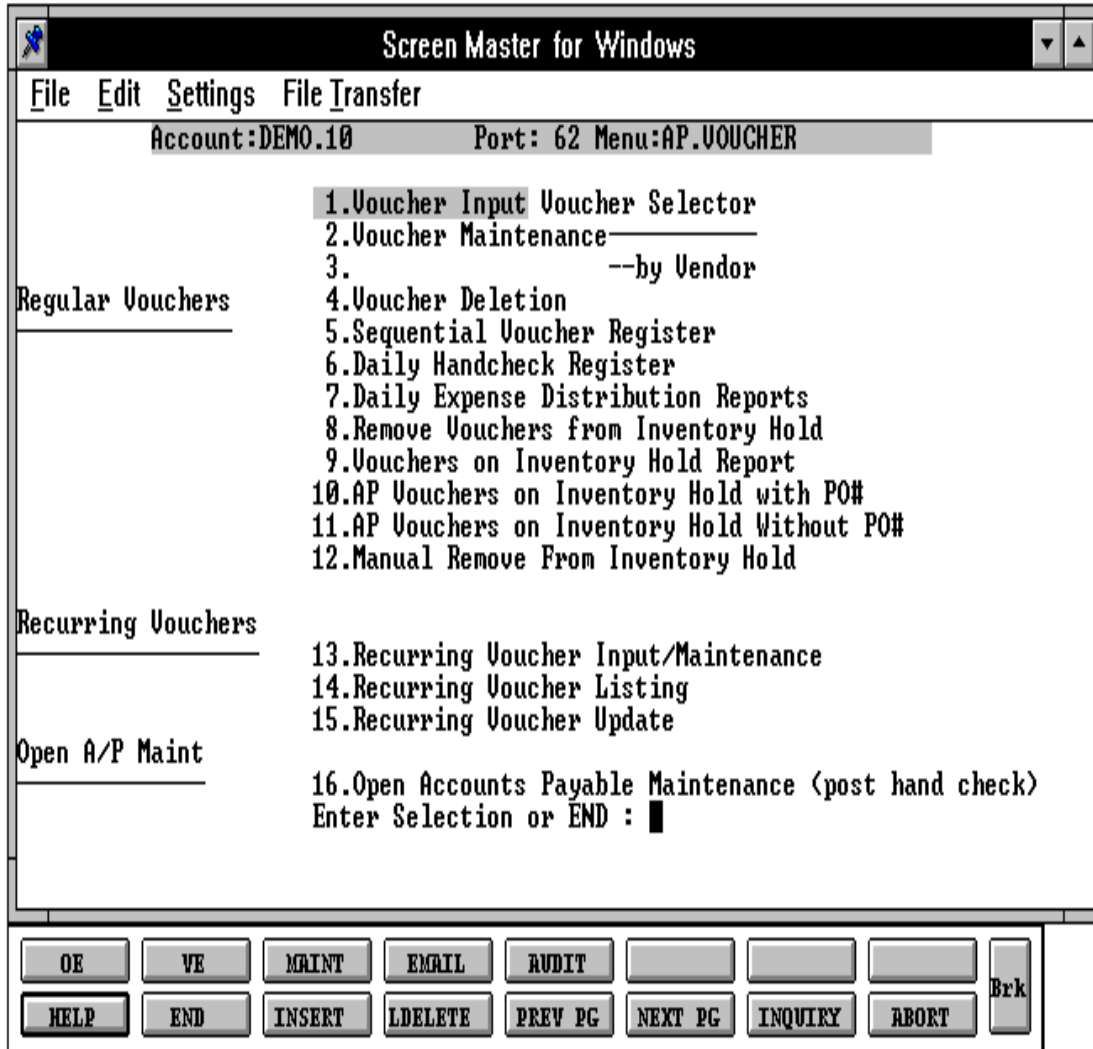

PURCHASE ORDER/ACCOUNTS PAYABLE INTERFACE

OVERVIEW - ACCOUNTS PAYABLE VOUCHER INPUT

1. When the vendor's invoice is received, it is entered into the system using the accounts payable voucher input program. The operator identifies the purchase order and receiver to which this vendor's invoice applies. Multiple purchase orders and/or receiving's may be identified on a single vendor's invoice by entry of each on a separate distribution line item.
2. To facilitate the matching process, the operator will have the ability to inquire into the status of receivers for a specific purchase order. At the prompt for the general ledger number, the operator may request an inquiry of open receivers for a specific purchase order. Upon entry of a purchase order number, the inquiry will display the following information on all receiving to this purchase order. The source of this information will be the Inv.Rcpt file.
 - a. Purchase Order Number
 - b. Receiver Number
 - c. Receipt Date
 - d. Total Quantity Received
 - e. Total Value Received
 - f. Total Value Received against the Purchase Order
 - g. Total Value Vouchered to Date Against this Receiver
 - h. Un-Vouchered Balance on This Receiver
3. The system insures that every transaction affecting an inventory account will eventually have a purchase order cross-reference entered, by placing all vouchers affecting an inventory account on inventory hold (see below). If the receiver is not known at the time of voucher entry, the document will be held in suspense (inventory hold), until it is properly matched via the voucher maintenance program. These inventory accounts will be identified via a flag in the CADF file (Category Code = "I"). Accounts without code "I" will not allow a purchase order/receiver reference to be entered.
4. All vouchers with a purchase order cross reference or with an inventory account general ledger distribution line will automatically be put on inventory hold, a separate attribute (44) from the normal payment status field. Vouchers will not be eligible for payment if they are on inventory hold.

PURCHASE ORDER/ACCOUNTS PAYABLE INTERFACE

OVERVIEW - ACCOUNTS PAYABLE VOUCHER INPUT (Continued)

5. The Inv.Rcpt file, the file in which the receiving information has been recorded, is updated with the voucher information, in addition to the update now performed to the Purchase Order file.

ACCOUNTS PAYABLE VOUCHER MAINTENANCE

The voucher maintenance will not have the ability to remove the inventory hold flag. The hold flag can only be removed by the comparison program identified below (batch matching). Voucher maintenance will retain the ability to put/remove a voucher on normal payment hold.

The Vou.Rcvr.Xref file is updated with the voucher number if any transaction is modified to include a purchase order, receiver cross reference.

The voucher maintenance program provides the ability to change the purchase order or receiver reference on any line item coded to an inventory distribution line. In addition, if the month has not been closed, the program allows a change to any of the data elements on the general ledger distribution line, including, the general ledger code, job number, and/or distribution amount.

BATCH MATCHING PROGRAM

A batch program will be initiated periodically from the accounts payable menu to compare the vouchers entered to the value of the corresponding receivers. The records in the Vou.Rcvr.Xref file are sorted in receiver order to facilitate this match. All records pertaining to a receiver are read in, and their total value accumulated. After all referenced vouchers for a specific receiver are read, their total is matched to the value of the receiver. If they are in balance, the following updates occur:

1. The Receiver (Inv.Rcpt) record is marked as in balance (the Stat.Cd is set to "C").
2. All corresponding records in the Vou.Rcvr.Xref file are deleted, or the associated receiver cross reference deleted from its value marked location in the record.
3. The associated vouchers are taken off inventory hold.

PURCHASE ORDER/ACCOUNTS PAYABLE INTERFACE**OPEN RECEIVER REPORT**

A report of all open receivers will be provided, driven off the Inv.Rcpt file. This report will display both the value of the receivers, as well as the corresponding vouchers received and their value open.

VOUCHERS IN SUSPENSE

As a follow up tool for the accounts payable department, a report will be written off the OAP file, listing in department sequence all vouchers on inventory hold. The source of the department will be the department of the first general ledger distribution line. If a receiver number has been entered against this voucher, then it will print on the report. Each time the report is run, a sequence number in the Voucher record will be updated and printed on the report in order to show how long this voucher has been in suspense.

OVERVIEW

This program is used to enter various transactions received from your vendors or issued to your vendor. Transactions include invoices (vouchers), credit memos, debit memos and on-accounts.

PARAMETERS USED IN VOUCHER INPUT

The following parameters are used in the voucher input program:

31. Is the job# input (Y/N)
32. The number of months in the future for which input is allowed.
34. Are batch controls used (Y/N)
39. Is the letter of credit system used (Y/N)
40. Is the A/P - P/O interface system used (Y/N)

BATCH CONTROL FOR VOUCHER INPUT

The batch control screen is initiated only if parameter (34) indicates that batch control is in use. The operator is prompted for the number of vouchers to be entered, as well as the gross dollar amount of the batches. At the completion of the batch, these figures will be compared to the actual number of vouchers entered and to the calculated gross total.

VOUCHER INPUT

BATCH CONTROL FOR VOUCHER INPUT (Continued)

If either of these totals are not in agreement, the screen displays both the entered and calculated figures and a message that the batch is not in balance. The operator is then given the option to continue to add vouchers or to end the voucher entry session.

A Batch Control record is established in the Vou.Con file, which retains the amounts input in the control screen as well as the actual voucher amounts input. When the daily sequential voucher listing is run, an open batch listing will be produced, as in the accounts receivable module. However, unlike receivables, even if the session is ended with the batch out of balance, the vouchers entered will be processed in the normal fashion.

Be sure to run the sequential voucher register to insure all batches are in balance prior to accounts payable month end, as the program will stop if there are any open batches for the fiscal period being closed in the file.

OPERATING INSTRUCTIONS

If batch control is used, this screen will be displayed and the following should be input:

CO#

Enter the company number the purchase should be recorded against.

PERIOD

Enter the fiscal period that the purchase should be posted to.

OF VOUCHERS

Enter the number of vouchers that you will be entering.

GROSS AMT\$

Enter the total gross dollar amount of the invoices, etc.

After this information is input, a batch number will be assigned and you will proceed to enter each voucher.

When option 1 is selected, the voucher input routine is started. If batch control was not used you will enter the following:

ENTER COMPANY NUMBER OR 'END':

The user is prompted for company number which is validated to Company file.

ENTER FISCAL YEAR AND MONTH (YYMM) OR 'END':

You are then prompted for the fiscal period. The period entered will be validated to the Company file to insure:

That the month is not already closed.

That the month entered is within the acceptable range of input, determined by the number of months in the future, which was specified in the Parameter file (32).

If batch control was used you will be prompted for the following prompts:

ENTER 'L' FOR LOOKUP, VENDOR NUMBER OR 'END':

The actual vendor code may be entered or, if not known, an 'L' may be entered to invoke the generic vendor lookup routine. The vendor lookup screen is displayed, and the user is prompted for a lookup code. The lookup code may consist of the first four characters of any word of the vendor's name.

All vendors matching this code will be displayed, along with a corresponding line number. The user may then select the line number of the appropriate vendor. Once the vendor is located on the VEND.MAST file, the name and address is displayed for verification.

IS THIS A TEMPORARY VENDOR? (RTN/N):

If the vendor is not on file, the user is questioned whether or not it is a temporary vendor. If it is, the name and address may be input by the user and are stored in the Vend.Mast file, flagged as a temporary vendor. If you wish to retain the temporary as a permanent vendor you must go to the vendor master maintenance program and change the flag (TEMP T/N) to 'N'. Temporary vendors are deleted from the system at month end if no activity has occurred vendor for 62 days.

VOUCHER INPUT

OPERATING INSTRUCTIONS (Continued)**IS THIS THE CORRECT VENDOR? (RTN/N):**

If this is the correct vendor hit 'RETURN'.

TERMS:

If the vendor has discount terms indicated, the operator is asked if the discount is to be taken. If the discount is to be taken, the due date is computed based upon the due date for discount contained in the Vendor Detail file. Otherwise it is based upon the normal terms in the same file.

TRANSACTION CD (I/C/D/OA):

Four types of transactions are accommodated by the voucher input program and are identified by a transaction code, which are as follows:

- I - Invoice received from vendor
- C - Credit memo received from vendor
- D - Debit memo issued to the vendor. The sign of both credit and debit memos are negative, and serve to REDUCE accounts payable.
- O/A - On account payments or vendor advances. The effect of this transaction is to create two (2) transactions: A DEBIT so that the advance check can be drawn, and a CREDIT memo in a like amount so that the total accounts payable balance is not changed when an on account voucher is entered. The operator is prompted for two due dates, the first for the check payment, and the second for the date of the credit memo.

INV#:

The vendor invoice number may consist of up to 15 characters. The Ap.Inv.Ver file determines if that invoice has already been entered for that vendor, to safeguard against duplicate entries. The invoice number will be retained for a period of 370 days, at which time the invoice number can then be repeated.

VOUCHER INPUT**OPERATING INSTRUCTIONS (Continued)****INV DT:**

Enter the date of the invoice. This will be used for calculation of due date.

DUE DATE (OR PAID)

The due date is calculated from the invoice date using either the discount or standard terms dating, both found in the Vendor Detail file. The due date can be overridden, or replaced with the word 'PAID' for handchecks.

HANDCHECK ENTRY

If the entry of PAID (in the due date field) is input, the payment bank, check date, and the check number must be entered. The Hdch and Apcheck files are searched to insure that the entered check number is not already in use. Optionally, a bank reference can be entered on hand checks to record bank draft information. After the voucher input is complete the daily handcheck register should be run, reviewed and updated if ok.

GROSS, MERCH, NON DISC, DISC:

The gross amount of the invoice must be entered, and agree in sign with the transaction type (i.e. positive for an 'I' nvoice, negative for a 'C' redit and 'D' ebit memos). The merchandise amount is the amount on which the discount (if the discount option is taken) is calculated. The operator has the option of entering either:

1. The discountable amount (MERCHANDISE) or
2. Non discountable amount

If neither is entered then the full amount of the invoice is assumed to be discountable. The discount amount will then be computed and displayed. The discount amount can be changed by the entry of an overriding discount percent or an actual discount amount.

MICRO#

6N - can be used for any purpose, intended for use to record an external reference number used by the MDS user.

VOUCHER INPUT**OPERATING INSTRUCTIONS (Continued)****PAYMENT STATUS CD:**

The vendor's payment status code (P-pay N-do not pay) is displayed from the Vendor Master and an override is permitted. Any invoice with a pay status of 'N' (do not pay) will be excluded for payment until the status code is changed.

NET:

The net amount of the invoice is displayed, based on what was entered in the gross, merch, non disc and disc fields.

BANK#:

If the bank number is entered at voucher input time, the bank number from the Vendor Detail file is displayed and override allowed.

If the Parameter file (35) indicates that the bank is entered at disbursement time, no prompt for bank occurs.

The bank number must be entered on handchecks, as well as the check number and check date.

SNG CHECK:

The operator is prompted if the voucher is to be paid on a separate check, as might be the case for payroll tax bank deposits.

**DO YOU WANT TO PAY THIS VOUCHER ON A SEPARATE CHECK?
(Y/N/NL):**

Enter 'Y' to pay this voucher on a separate check, enter 'N' or 'RETURN' to pay on one check.

MISC DESC:

30 A/N - can be used for any purpose, intended for additional descriptive data about the voucher, which can be printed on the check stub.

VOUCHER INPUT**OPERATING INSTRUCTIONS (Continued)****LETTER OF CREDIT NUMBER**

If the letter of credit system is used and the voucher entered is a handcheck, the user is prompted if a letter of credit payment applies.

If 'Y' is entered the system prompts for the letter of credit number.

The payment is applied to the open balance of the letter of credit providing the following criteria has been met:

1. The bank number entered must match the bank number that the letter of credit was issued through.
2. The fiscal period of the voucher is not less than the fiscal period that the letter of credit was issued.
3. The letter of credit is not expired.

Prior to accepting the header portion of the voucher, options are provided to change or delete the input information thus far.

ENTER LINE# TO CHANGE, 'DELETE' TO DELETE OR '0' TO ACCEPT THE VOUCHER HEADER.

Enter the line number to change, delete to delete the header and restart or '0' to accept the voucher header and advance to the detail portion of the voucher.

After the header portion of the voucher is approved by the operator, a voucher number is assigned and displayed. The voucher number is composed of the company number concatenated with a six digit number assigned in the company, from the Sequence Control file.

If standard general ledger numbers were entered for that vendor in the Vendor Master file, they are displayed for reference purposes. If a 'RETURN' is entered for the general ledger number, the first standard general ledger code contained on the Vendor Master file is used if they have been set up. If no general ledger numbers have been assigned in vendor maintenance, the general ledger numbers must be entered. 'L' for lookup can also be used to begin an inquiry for the general ledger and department numbers.

JOB NO

If the Parameter file (31) is flagged for use of job numbers and a job number is entered, it is validated against the Job Master file. If valid, the number is stored on the vouchers and OAP files. The distribution amount will be updated to the Job Master file at the accounts payable end of month.

PO#

If at the PO# prompt a valid purchase order number is entered, and the general ledger account type is an 'I' the distribution amount is compared to the un-vouchered amount of the PO. If the distribution amount is less than or equal to the balance remaining on the PO, the vouchered amount is updated. If the PO is invoiced and received complete, it is flagged as closed. If the distribution amount is greater than the un-vouchered amount of the PO receipt, then an error is displayed showing the un-vouchered amount of that receipt. The operator may accept the amount entered or correct it. If it is accepted, the PO will then print on a PO exception report and the PO must be manually closed through PO entry or corrected through PO adjustment program. (Parameter file #40 AP/PO Interface must be set to 'Y' in order to use the purchase order and receiver number fields.)

RECEIVER#

At the receiver number prompt a valid receiver number must be entered for the PO# entered. 'I' can be entered at the receiver number prompt, to display all the receivers for the purchase order number that was entered. You may then select the receiver and 'END' to return to the receiver number prompt with the receiver number selected. The program will validate the PO/REC# combination and verify voucher distributions made (if any) against it. The voucher will go on inventory hold until the batch matching program is run to remove vouchers from inventory hold.

VOUCHER INPUT

OPERATING INSTRUCTIONS (Continued)

DIST AMT

If <RETURN> is hit for a distribution amount, the remaining balance of the voucher is made to the distribution amount for the line. The distribution amounts can also be applied manually to multiple accounts.

After the distribution amount is entered for each line, the user can go back to the beginning of that line by entering an 'N' in the approval field.

The next general ledger account will be prompted for if the distribution amount does not equal \$ 0.00.

If the distribution amount equals \$ 0.00, you will be prompted:

FOR NEXT SCREEN, 'ADD' TO ADD DISTRIBUTION LINES OR 'DELETE' TO

If you want to change a distribution line, you must enter that line number. If you want to accept the voucher as entered, enter '0' and return. If you have more than one screen of distributions, enter 'RETURN' to see the next screen. Enter 'DELETE' if you want to delete the voucher.

When the distributed amount equals the gross amount, the voucher is considered complete and the data is stored. The process then returns to the vendor number prompt. A voucher cannot be updated unless the entire amount of the invoice is distributed.

The voucher maintenance program allows the changing of the following fields:

1. Invoice Date
2. Due Date
3. Gross Amount
4. Discount Amount or Percent
5. Payment Status
6. Bank Number
7. Single Check
8. Miscellaneous Description
9. General Ledger Distribution
10. Gross Amount (if voucher does not have a payment against it)

Any other changes will require the deletion of the voucher, and its reentry as a new voucher. If the voucher is for a previous period, the general ledger distribution can still be changed if the voucher is still open. If the voucher has been paid in the current period, the general ledger distributions can still be changed (gross amount cannot be changed).

If parameter (35) is set to a 'Y', indicating that the bank is entered at disbursement time, the program will not allow changes to the bank number. If this is an inventory voucher the voucher will go on inventory hold and the remove vouchers from hold program should then be run.

VOUCHER MAINTENANCE

OPERATING INSTRUCTIONS

ENTER COMPANY NUMBER OR 'END':

Enter the company number for the voucher or 'END'.

ENTER VOUCHER NUMBER OR 'END':

Enter the voucher number (without the company number) or 'END'.

The operator is prompted for the company and voucher number to be maintained. The program steps through the fields that may be maintained, and then prompts:

The cancel option will only cancel the maintenance NOT the voucher.

Run the sequential voucher register, an * next to the voucher designated that maintenance has been performed to the voucher.

The voucher maintenance by vendor program will retrieve all open invoices for a vendor, and provide a quick way of maintaining the open invoices for a vendor in preparation for check writing. The following fields may be maintained:

1. Invoice Date

6. Single Check

OPERATING INSTRUCTIONS

The operator is prompted for the vendor to be maintained:

The single check flag may be changed.

NOTE: The voucher must be in an open status on the OAP file in order for maintenance to be performed.

After the above fields have been edited, the program prompts:

IS THIS WHAT YOU WANT (RTN/N) ?

If 'RETURN' is entered, the program will re-file the voucher and display the next open voucher for the vendor, or return to the vendor prompt if there are no other open vouchers for the vendor.

If 'N' is entered, the program will re-prompt for the input fields.

The voucher deletion program is used to delete those vouchers that were entered in error, or that should not have been entered.

If the voucher is on either the Hdch file or the Oap file it can be deleted. However, as a protection against a bad entry, an open payables item cannot be deleted once it has been paid, either in full or part.

If batch controls are in use (parameter 34 set to 'Y') then the batch controls for the appropriate batch are updated, to reflect the deletion.

If the letter of credit system is used (parameter 39 set to 'Y') and the voucher being deleted was applied to a letter of credit, the letter of credit is updated to reflect the deletion.

The fiscal period of deletion, will be the period used in the entry of the voucher except if that period has already been closed. In that case the current fiscal period (stored in the company file) issued.

To accomplish the deletion a 'Y***' must be entered.

Enter the company number for the voucher or 'END'.

The open accounts payable maintenance program is designed to allow payment of the open payables items without the creation of an actual check. The methodology used is identical to that used on the creation of computer generated checks. However, the check number is assigned from a separate number series stored in the Bank file (next washout number).

The operator also has the option of entering a different check number than the one assigned from the Bank file. In this way, the maintenance program may be use to record the entry of a hand check.

The operator is asked for the fiscal month and the voucher to be paid. The program prompts for the amount of each voucher that is to be 'PAID'. The check register should be printed and updated immediately after the maintenance is completed.

If the Parameter file indicates that the disbursement account is entered at disbursement time, the bank number and bank general ledger number will now be stored in the voucher on the Check Register file.

You may also use this program to apply vendor credits against open voucher.

The primary use of this program is to accurately record payments made through bank drafts or other commercial payment forms.

Open accounts payable should not be done during the cash disbursement procedure.

Option 4 on the cash disbursements selector initiates the disbursement of cash to all vouchers with a due date less than or equal to a date that the user enters when prompted.

OVERVIEW

This procedure allows the user to select specific vouchers for payment. This procedure would normally be used in conjunction with due date check writing, to allow the inclusion of specific vouchers not meeting due date requirements.

Since this procedure initiates the cash disbursement process, no voucher deletion, maintenance or washout entry should be done at this time.

OVERVIEW

The program in this module allows the customer to control outstanding and cleared checks through the various accounts payable bank accounts. The check number, vendor name and check amount will be displayed and can be cleared.

To simplify entry, the operator is asked for the range of checks to be cleared. In the input program, each check in the range is sequentially displayed, and the operator is prompted for the input of the 'CLEARED' information.

The input program provides both an entry and inquiry option, the inquiry being provided to allow the operator to determine the cleared status of a particular check. Once a check has been cleared and deleted from the Apcheck file, it is no longer available for inquiry and can not be voided.

Several reports are available from the system to control the reconciliation.

DATE EXPIRED - expiration fiscal period.

OPEN BALANCE - if there is an open balance it will display.

When the letter of credit expiration notification is received from the bank, the expired indicator is entered as 'Y' and the actual date of expiration and fiscal period of expiration are entered. COMPANY

This file holds pertinent information for each company as defined by the MDS client. A maximum of 99 companies may be defined. The company name stored in this record is used as the heading for the various reports throughout the system. In addition, the prompt mask and next internal number to be used for the Product and Customer files are also stored in the record.

BANK

This file is used to define the various bank accounts used for each company. The asset general ledger account is stored in this record, as well as descriptive information about the bank account.

This file is used by the accounts receivable, accounts payable and payroll modules.

1099.FILE

The 1099 file is used to store all payments made to vendors, who have been coded to receive 1099's. All 1099 vendors should be flagged as such in the Vendor Master. The actual printing of the 1099 forms uses this file to obtain the detail information.

1099 forms may be printed and also transferred to tape for the IRS.

This file is updated during accounts payable monthly jobstream.

AP

Accounts Payable Program file.

AP.P

Accounts Payable Prok file.

APCHECK

Bank Reconciliation file.

ACCOUNTS PAYABLE FILE DESCRIPTIONS**AP.INV.VER**

The Ap.Inv.Ver file is used to insure that vendor invoices are not entered more than once. The key to the file is vendor number, vendor invoice number. In the voucher input program, upon entry of the vendor's invoice number, this file is checked to determine if this invoice has already been vouchered. If on file, the operator is prohibited from entering the invoice a second time.

If the invoice is not found on file, a new entry is generated, and maintained on the system for a period of 13 months.

CKP

Vouchers selected for payment are copied from the Oap file to the Ckp file. The check print routine reads this file to create the actual accounts payable checks.

CKR

This file is written to during the check print/update process and is used to produce the accounts payable check register.

DUMP-OAP

As records in the Open Accounts Payable file are deleted, they are transferred to the Dump-Oap file for historical purposes during the Accounts Payable end of month jobstream. This file can be purged on a cycle selected by the MDS user.

HDCH

This file contains all handchecks processed that have not been updated to the monthly handcheck file (Mon.Hdch).

H.VOUCHERS

The H.Vouchers file contains a cumulative listing of all the distribution amounts of each voucher entered in to system. Its source is the Vouchers file and is updated monthly. The contents are used to produce the annual cumulative expense distribution reports. The H.Vouchers are maintained for 13 months and are purged off the system at accounts payable month end.

ACCOUNTS PAYABLE FILE DESCRIPTIONS**JOB**

The Job Cost Summary file contains monthly and annual accumulations of charges to projects by general ledger. Its update source is the Vouchers file, which will update the JOB file if a job number has been input during voucher entry. If the Job.Desc has been deleted end of month will delete the job information.

JOB.DESC

Contains the alphanumeric descriptions of the valid jobs used in the accounts payable system.

JOB.HIST

The Job.Hist contains the detail that is posted to the Job file. This file is updated during the end of month jobstream and is used for the detail listing.

LETTER.CREDIT

The letter of credit file contains the open item detail of each letter of credit on the system. Each amendment and payment record is stored in this file until the letter of credit is expired.

Deletion of expired items is performed under control of the MDS user.

LETTER.CREDIT.XREF

This file is a cross reference of all letters of credit for a given vendor.

MCD

The Monthly Cash Disbursements Summary file updates general ledger during accounts payable month end jobstream.

MON.CKR

This file is used to print the monthly check register report, and to update the 1099.File. It is purged at end of month.

ACCOUNTS PAYABLE FILE DESCRIPTIONS**MON.HDCH**

This file is used to print the monthly handchecks register, and to update the 1099.File. It is purged at end of month.

OAP

The Open Accounts Payable file contains the open item detail of each voucher open on the system. Check payment record is stored in the file, until the voucher is fully paid.

Deletion of paid items is performed at month end, after being copied to Dump.Oap.

SQV

The Sequential Voucher file is used to produce the sequential and monthly voucher reports. Its contents are commonly referred to as the Purchase Journal. The records for the specific month is cleared at accounts payable month end.

VEND.MAST

One Vendor Master record is maintained for each of the client's vendors. Generally, this file contains all static data relative to that vendor such as name and address information, D&B number, telephone number and various indicator fields.

VEND.DET

The Vendor Detail file contains one record for each vendor, for each company that vendor deals with. The file contains basic purchase and payment history for the vendor, as well as terms of payment.

VEND.INV

This file is a cross reference of all open invoices for a given vendor.

VEND.INV.HIST

This file is the cross reference for the Dump.Oap (History of Open Payables).

ACCOUNTS PAYABLE FILE DESCRIPTIONS**INV.RCPT**

Cross reference of PO receipt by receiving number

VOU.CON

The Vou.Con file is used by the system when the batch control option is used by voucher entry, as determined by the parameter record ATTR 34. The key is the batch number. The record contains company number, fiscal period, the number of vouchers, and the gross amount of the batch.

VOU.RCVR.XREF

This cross-reference file will be used to match vendor invoices (vouchers) to inventory receipts. The key to this file will be the voucher number, ATTR 1 will store a list of all receivers applied to this receiving. This file will be updated by the voucher input and maintenance programs.

VOUCHERS

The VOUCHERS file contains the distribution amounts of each voucher entered into the system. Its contents are used to produce the Expense Distribution reports, and to ultimately update the General Ledger (Gla) file. The records are copied to the H.Vouchers and the records for that specific period are deleted from the Vouchers file.

VOUCHRECC

This file contains all recurring vouchers, and contains all the information necessary to transform these entries into actual vouchers.

GENERAL LEDGER FILE DESCRIPTIONS

CA

Chart of Accounts file. The Ca file is the system Chart of Accounts file, containing in summary all monthly activity pertaining to each general ledger account. Budget and statistical information are stored in this record as well.

CADF

Chart of Accounts Description file. This file contains the description for each natural account. The category code has been expanded to allow "I" to identify an inventory account. This field will be verified by voucher input to insure that on all inventory purchases a receiver is entered. It also contains the information needed to link the chart of accounts to the financial reporting module.

CASDF

This file contains the description of each department and/or cost center.

FIN.PROG

The Financial Reporting System Program file.

FIN.RPT

The Financial Report Work file. This file is updated from the Ca (Chart of Accounts file), and is used to prepare financial reports.

D.FIN.RPT

This file is used for financial reports with percent calculations.

GL

GL is the program file for the general ledger system.

GL.P

This is the Proc file for the general ledger system.

GENERAL LEDGER FILE DESCRIPTIONS

GL.SOURCE

The Gl.Source file contains an index of valid source code designated in the general ledger system.

GLA

The General Ledger Activity file contains all the detail for updating the chart of accounts. Entries are generated into this file from all external systems affecting the general ledger, such as accounts payable, fixed assets, cash receipts, sales, etc. In addition, the various journal entry programs create transactions into this file after their proof listings have been accepted.

At month end, all transactions for the closed month are selected from this file, used to update the Ca file, copied to the Gla.Hist file and deleted from the Gla file.

GLA.HIST

The Gla.Hist file contains a copy of all general ledger update transactions (from Gla), which have already been updated to the Ca file. Its purpose is to create an audit trail, as well as to provide a cumulative, detailed general ledger.

GL.INQ.XREF

This file is used to facilitate the General ledger history inquiry. It contains a value marked string of all entries pertaining to a general ledger Account.

The file contains the keys to all records in the Gla.Hist file for a specific company-natural account number. The file is updated as part of the general ledger month and year ends.

GLM

Detail General Ledger Print file. This file is used to print the post-closing general ledger detail report and should be cleared after the report is run.

JE

Journal Entry file. This file contains only journal entries input through journal entry maintenance and not yet updated.

GENERAL LEDGER FILE DESCRIPTIONS**JE-REV**

Auto-reverse Journal Entry file. This file contains any auto-reversing journal entries not yet updated.

JERECC

Recurring Journal Entry file. This file contains all recurring entries to be used for updates to the JE file.

P&L.DESC

The Profit and Loss Description file contains the layout of the financial reports. It is used in the preparation of financial statements.

P&L.RPT.DATA

This file contains a copy of the financial reports with total lines. The file is not used for any reports however, it can be used to download the information to a PC or Spreadsheet file or for custom designed reports for additional analysis.

PGLM

Preliminary Detail General Ledger Print file. This file is used to print the pre-closing general ledger detail report.

REDIST.GLA

This file contains the general ledger activity created by the allocation entries.

REDIST.JE

This file contains the allocation entries.

TEMP.CA

The Temp.Ca file is used to prepare a preliminary trial balance prior to the close of the fiscal month. It is a copy of the current CA file, updated with the current months Gla transactions. Each time the Temp.Ca update is run the file is cleared and rebuilt.

GENERAL LEDGER FILE DESCRIPTIONS

TEMP.REDIST.GLA

This file contains the preliminary general ledger activity created by the allocation entries.
